DECISION
ON
REQUIREMENT AND REGISTRATION FOR
BOARD OF NATIONAL DENTAL COUNCIL

- Seen the constitution of the Kingdom of Cambodia.
- Seen the Royal decree No. 0913/903 dated on September 20, 2013 on the appointment of the Royal Government of Cambodia.
- Seen the Royal Code No. 02/94 dated on July 20, 1999 which promulgated on the arrangement and the conduct of Ministerial Council.
- Seen the Royal Code No.1100/10 dated on November 03, 2000 which promulgated on the governance of private professional practice in medical sector, paramedical and medical assistant.
- Seen the Royal decree No. 0905/396 dated on September 02, 2005 on the establishment of the Dental Council of Cambodia.
- Seen Sub-decree No. 94 dated on September 06, 2009 on the process and requirements for granting the foreign medical practitioners, paramedical, and medical assistant to practice private profession in the Kingdom of Cambodia.
- Seen Sub-decree No. 1356 dated on September 10, 2014 on the recognition of Board Component of National Dental Council.
- Seen the decision No. 0019/15 dated on March 26, 2015 on the internal regulations in the Dental Council of Cambodia.
- According to the mandatory requirement.

DECIDES

Article 1:

All National and Foreign Dentists who wish to practice in medical profession in the Kingdom of Cambodia, it's required that such application for registration must be obtained from the Dental Council of Cambodia.

Article 2:

National Dentists who wish to register with the Dental Council of Cambodia must meet with the following requirements:

- A- Possess a Dental Certificate which issued by any higher educational institution in the Kingdom of Cambodia or abroad and with lawful certificate recognition and existing regulations of the Kingdom of Cambodia.
- B- Has never been convicted by court/judiciary.
- C- Fill out/complete the application for registration to align with the application format of the Dental Council.

Article 3:

Foreign Dentists who wish to register with the Dental Council of Cambodia must meet with the following requirements.

- A- Be able to speak Khmer and /or English language.
- B- Possess a Dental Certificate which lawfully recognized and existing regulations of the Kingdom of Cambodia.
- C- Has never been convicted by court/judiciary.
- D- Become or is a member of Dental Council from the respective country.
- E- Continuing Professional Development (CPD)

Article 4:

All National and Foreign Dentists who wish to further maintain the validity as the members of the Dental Council of Cambodia must meet with the following requirements:

- A- Fill out/complete the application to further extend the validity of one month prior to the deadline.
- B- Has never been convicted by court/judiciary.
- C- Continuing Professional Development (CPD).

Article 5:

Registration in the Dental Council of Cambodia, Candidates who are the national dentists must.

- A- Maintain permanent resident from the respective municipality and province.
- B- Possess a Dental Certificate affirmed by the competent authority.
- C- Obtain a letter of a criminal record.
- D- Have a comprehensible knowledge with code of conduct and other regulations which are relevant to the Dental Profession.
- E- Fill out/complete the application for registration to align with the application format given by the Dental Council of Cambodia.
- F- All application's requests to be decided by Municipal and Provincial Dental Council within the period of one month, is the longest starting from the day of receiving the application.

Article 6:

Registration in the Dental Council of Cambodia, Candidates who are the foreign dentists must.

- A- Hold a proper passport with specific validation of Visa type E and during the length of working.
- B- Maintain a permanent resident in the Kingdom of Cambodia.
- C- Possess a Dental Certificate certified by the Embassy or by the respective country.
- D- Obtain a validity of criminal record from the respective country.
- E- Have a comprehensible knowledge about the code of conduct and other regulations which are relevant to the Dental Profession.
- F- Be able to speak Khmer and /or English language.
- G- Obtain a validation letter which affirmed as the members of the Dental Council from the respective country.
- H- Fill out/complete the application for registration to align with the application format given by the Dental Council of Cambodia.
- I- All application's requests to be decided by National Dental Council within the period of two months, is the longest starting from the day of receiving the application.

Article 7:

Board of the National, Municipal and Provincial Dental Councils are required to fully implement this decision.

Article 8:

Any other decision in contradiction with this decision shall be annulled.

Article 9:

This decision comes into force on the date of signing.
